

Rights of the data subject (Art. 15 to 22 and Art. 13 of GDPR)

Right of access	According to the provisions of Art. 15 of the GDPR, the data subject has the right to request the owner access to their personal data.
Right to rectification	According to the provisions of Art. 16 of the GDPR, the data subject has the right to request the owner to rectify their personal data.
Right to erasure	According to the provisions of Art. 17 of the GDPR, the data subject has the right to request the owner to delete their personal data.
Right to restriction	According to the provisions of Art. 18 of the GDPR, the data subject has the right to request the owner to restrict the processing of data concerning him.
Right to object	According to the provisions of Art. 21 of the GDPR, the data subject has the right to object to the processing of their personal data.



Right to withdraw	According to the provisions of Art. 7 of the GDPR, the data subject has the right to withdraw their consent.
How to exercise your rights	By sending a request, accompanied by an identity document for identification purposes, to sgm@new-tem.com .
Additional Notes	The data subject has the right to lodge a complaint with a supervisory authority (for example the guarantor of personal data protection)
